## II अधिसूचना II

एतद् द्वारा अधिसूचित किया जाता है कि कार्यालय आयुक्त, उच्च शिक्षा संचालनालय, ब्लॉक-सी-30, द्वितीय एवं तृतीय तल, इन्द्रावती भवन, नया रायपुर के पत्र क्र. 1900/05/आजशि/समन्वय/2018 दिनांक 06.08.2018 के द्वारा विश्वविद्यालय समन्वय समिति की बैठक दिनांक 19.04.2017 के प्रस्ताव क्रमांक 13, Revised Ordinance-107 - BACHELOR OF COMPUTER APPLICATION (BCA) को राजभवन रायपुर द्वारा अनुमोदित किया गया है, जो निम्नानुसार है -

### REVISED ORDINANCE - 107

(Under Section)

#### BACHELOR OF COMPUTER APPLICATION (BCA)

1. The Degree shall be known as Bachelor of Computer Application (BCA).
2. The duration of this course is extended over three academic sessions. These three years full time course has been broken into three parts:  
Part I - Known as BCA Part-I  
Examination at the End of First Year  
Part II - Known as BCA Part-II  
Examination at the End of Second Year  
Part III- Known as BCA Part-III  
Examination at the End of Third Year
3. Eligibility for Admission :  
The minimum qualifications for admission to the BCA course shall be Higher Secondary (10+2) with Mathematics as one of the compulsory subject from any state board or central board or any other examination recognized equivalent there to by the University for the purpose. If the candidate does not have mathematics at 10+2 level as one of the compulsory subject then he/she may be provisionally allowed to take admission in the course subject to clear "Maths Bridge Course" along with the other compulsory papers. Board of Studies (BoS) of the University shall be authorized to prepare syllabus for Maths Bridge Course and to take any decision in this regard.

OR

Three Years Diploma Course in any discipline of Board of Technical Education, conducted by government of C.G. or other state government or its equivalent.

4. Student has to clear bridge course examination before appearing in the examination of third year of the course.
5. Bridge course shall not be treated as a core subject and hence will not be counted for supplementary examination and also not be considered for deciding division. Examination for bridge course shall be conducted along with supplementary examination also.

6. The admission to BCA course shall be made on merit basis and procedure is to be decided by the affiliated Colleges or University and any decision taken by the University in this regard shall be final.
7. English shall be the medium of instruction of examination for the course of study. However students may write in Hindi as well during the examinations.
8. The student admitted to BCA course shall not be permitted to appear in any other examination.
9. The BCA Course shall consist of: Schemes, Courses/ Papers and Practical's/ Projects as prescribed by concern Board of Studies from time to time.
10. A Student shall be declared pass at any part of BCA examination if he/she obtains at least 33% marks in each theory, 40% in each sessional and 50% in each practical along with 40% aggregate marks in each year of BCA course.
11. Students having less than 40% marks in aggregate will be declared as unsuccessful (Fail), and student shall be allowed to appear in forthcoming examination in any of the two papers of his/her choice.
12. A candidate who fails to obtain 33 % marks in theory and 50% marks in practical in any one or two papers in any part of the examination shall be eligible to appear in the Supplementary examination of respective paper conducted by the University.
13. A candidate, who fails to obtain minimum marks in sessional of any paper, he/she will be treated as Ex-Student and will have to appear in all theory and practical papers in the next year examination and will have earn requisite sessional marks.
14. In practical papers – An examiner will examine each examinee individually through records and viva-voce examination and by giving two or more exercises individually; duration of examination will be of three hours for each theory and practical paper.
15. A candidate declared pass at the BCA Part-I examination shall be eligible to be promoted to the BCA-II and shall be eligible for appearing in the BCA Part-II examination.
16. A candidate declared pass at the BCA Part-II examination shall be eligible to be promoted to the BCA-III and shall be eligible for appearing in the BCA Part-III examination.
17. A candidate who secures 60% or more marks in total aggregate of Part-I, Part-II and Part-III examinations shall be awarded First Division.
18. A candidate who secures less than 60% but greater than or equal to 45% marks in the total aggregate of marks shall be awarded Second Division.
19. A candidate who secures less than 45% but greater than or equal to 40% marks in the total aggregate of marks will be awarded Third Division.
20. For determining the division of such candidates who has passed the examination through the supplementary examination, actual marks obtained in the papers at the supplementary examination shall be included.
21. For the candidate failing in the Supplementary Examination of BCA Course, the provisions applicable for B.Sc. Examination of this University will be applicable.

22. A candidate not permitted to take up the any Part of examination due to shortage of attendance, shall be required to apply for admission as a fresh candidate in the next academic session.
23. The provision for revaluation in BCA course shall be same provided as B.Sc. Course of the University.
24. For the rules not defined here, the rules for B.Sc. Degree Examination at university shall apply here and in case of any conflict Board of Studies shall be empowered to take the decision accordingly.
25. The admission so granted shall be governed by the University rules applicable to all the students in the University and the decision of the Vice Chancellor in all cases shall be final.
